## INFORMATION FACTORS:

On February 2<sup>nd</sup>, Cst. Cleary-Porritt was dispatched to a collision at the intersection of Moira St. and Palmer Rd. The collision was of a serious nature, with injuries and involved a fire of one the vehicles.

### INFORMATION FACTORS:

On Sunday, March 3<sup>rd</sup>, 2024 Cst. Khoby Langdon & Cst. Brenden Frazer observed a male sitting on a railing of a train overpass on Sidney Street.

The officers stopped and engaged the male person in a conversation, during the brief conversation with the male, both officers realized he was in mental distress.

The officers tried to convince the male to turn around and get off the railing by his own volition. When the male failed to comply with the direction by the officers, they quickly devised a plan to grab him and take him into custody under the Mental Health Act.

The male person was successfully rescued from the bridge and transported to the Belleville General Hospital to be assessed by a medical practitioner.

The male person sent in a letter of appreciation to the officers saying that they saved his life and that "this is medal stuff," of which I completely agree with the male person.

Both of these officers are to be commended for their powers of observation and for their quick action to save the life of this member of our community.

## INFORMATION FACTORS:

On February 28th Cst. Conner O'Hara was dispatched to a call for service with respect to a wellness check on a male.

Upon arrival Cst. O'Hara met with the grandmother of the male person who indicated that he may be in the garage. The door to the garage was tied shut from the inside of the garage and as Cst. O'Hara was inside the house he had to force the door open.

Upon entry into the garage, he noted male person hanging from a rope and commenced to cut the male down, proceeded with a sternum rub and then placed the male in the medical recovery position.

Paramedics attended to the scene and transported the male to the hospital for medical treatment. The male person survived this suicide attempt.

Cst. O'Hara is to be commended for his quick attendance at the call and his lifesaving efforts. It should be noted that the male person was just a few seconds away from death.

It was further noted that, annually, 223 hours are expended by frontline Officers responding to false alarms, equating to a cost of \$30,000.00.

Inspector Meeks covered the VAR Program criteria and the expected results from the implementation of same.

Inspector Meeks requested approval to approach City Council for the appropriate By-Law amendment.

Chief Callaghan noted that Inspector Meeks and Staff Sergeant Ashley, with a view to finding cost-savings for the Service, undertook this strategic review and that a media campaign will be commenced prior to the implementation of the new Program.

# Belleville Police Service Courts Services

The unit consists of police officers, special constables, and three civilian support staff, two full time and one part time, who maintain an office at the court facility.

# **Court Office**

The Court unit liaises with the Crown Attorney, Court Administrator, Provincial Prosecutors, Probation Office and Victim/Witness Services as well as other police and civilian agencies with a view to ensuring that police charges are properly prepared and processed through the courts. They are also responsible for providing service in relation to serving court-related documents, court appearances, bail hearings, trials, transfer of charges as well as maintaining accurate and timely records on Niche and CPIC. Members of the unit are in frequent contact with a host of other police services and agencies such as the Judiciary, Defence Counsel, Court Administrative Staff, public and private agencies regarding victims and offenders as well as the general public. The Unit prepares Criminal Code information for charges stemming from court matters (i.e. failure to appear in court), prepares charges on behalf of the probation officer, and notifies and cancels witnesses as required. Additionally, the unit


ensures that Crown instructions for pending court proceedings are relayed to officers.

During the fourth quarter of 2023, 51 Criminal Code charges were processed and laid by the Court office staff which was is a 47% decrease compared to the 97 charges laid in 2022.


# What is a bail hearing?

If police do not release the person who has been arrested, they must bring the person before a justice for a bail hearing within 24 hours or as soon as possible. A bail hearing is a procedure where a judge or a justice of the peace determines whether a person charged with an offence should be released or held in custody pending trial. On the appearance date, the accused may enter into a consent release situation whereby certain conditions are agreed upon and must be followed, elect to run a hearing to be released if there is no consent by the Crown for release, or ask that the hearing be adjourned in order to find a suitable surety to attend court to assist with the release conditions and supervising the accused.

During the fourth quarter of 2023, there were a total of 339 instances where an officer was required in court with regard to a bail hearing being scheduled, whether it was a first appearance or an additional appearance due to an adjournment. This is a 33% increase compared to the 254 appearances in 2022.

# Court Security - Special Constables

Special Constables are civilian members who play an important role within the Belleville Police Service. Once hired, the Chief of Police swears in members as Peace Officers. Special Constable is a designation issued by the province of Ontario providing members with a limited Law Enforcement role in the City of Belleville.


The Special Constables ensure the security of Justices, Judges, Justices of the Peace, Court staff, all occupants of the courthouse, all persons taking part in or attending court proceedings, and the security of court buildings during the hours when the courts are operating. They provide professional care, custody, and transportation of people who are in custody from various detention facilities as well as anyone taken into custody during court proceedings. The unit escorts prisoners within the courthouse to ensure timely, safe and secure appearances in the required courtrooms.

Special Constables are responsible for fingerprinting and gathering DNA samples for the DNA Data Bank. Under the Canadian Criminal Code, Judges can order those convicted of designated offences to provide samples for DNA analysis. Young offenders can be included in the DNA Data Bank. The DNA Data Bank helps investigators identify suspects, link crime scenes where there are no suspects, eliminate suspects, and determine if a serial offender may be involved in a crime. DNA kits are prepared by the RCMP National DNA Data Bank and supplied to the Service. The Special Constable has to take the Offender's fingerprints and blood droplets for submission. They are also used for special events, subpoena service, ground searches, and any other duties assigned by the Supervisor to assist other units. The Unit completed 18 DNA court-ordered samples in the fourth quarter of 2023 compared to 14 DNA samples taken in the fourth quarter of 2022 representing a 29% increase.

As part of the Court Security Plan, Special Constables staff the entrance of the courthouse to operate the magnetometer and x-ray machine in order to screen individuals entering the courthouse. They are looking for any items that may pose a security risk such as guns, knives, scissors, etc. If an item is found, the individual is given the option of removing it from the courthouse to allow entry or forfeiting it for destruction. There were no items seized during the fourth quarter of 2023 or 2022.

The following graphs indicate the number of persons screened during the fourth quarter of 2023 for a total 6 697 compared to 5 774 in 2022, which is a 16% increase.





The Quinte Courthouse serves two Police Services, four OPP detachments and the Military Police within the County of Hastings: Belleville Police Service, Tyendinaga Police Service and the Military Police, Quinte West OPP, Centre Hastings OPP, North Hastings OPP and Prince Edward County OPP (for bail hearings only).


Prisoner transportation is shared between the Belleville Police Service and Quinte West OPP who supply two Special Constables to operate their prisoner transport vehicle. There is the requirement to attend at the Quinte Detention Centre (Napanee) in the morning to pick up prisoners and then to return the prisoners at the conclusion of court. On a weekly rotation basis, Belleville Police Service is responsible for either the morning transport or the afternoon.

The following graphs indicate the number of prisoners transported during the fourth quarter of 2023 for a total of 344 (68% increase from 205 in 2022) prisoners; 198 (38% increase from 144 in 2022) Belleville Police Service prisoners, and 146 (139% increase from 61 in 2022) prisoners for the other services and OPP detachments.











The following graphs indicate the number of prisoners handled at the Quinte Courthouse. This is where a prisoner is arrested the day before or day of the court appearance. The prisoner is not transported on the escort wagon and would not be captured in the transportation stats. In this case, the prisoner would attend the courthouse to be housed, escorted to the courtroom, and released.

In the fourth quarter of 2023, the number of prisoners transported was 344 compared to 442 prisoners handled.

The following graphs indicate the number of prisoners handled during the fourth quarter of 2023 for a total of 442 (75% increase from 252 in 2022) prisoners; 251 (44% increase from 174 in 2022) Belleville Police Service prisoners, and 191 (145% increase from 78 in 2022) for the other services and OPP detachments.

# **Total Crimes:**

The total number of crimes reported during the fourth quarter of 2023 was 1281 (111 unfounded) for an actual of 1170 "crimes" compared to 1001 crimes reported during the fourth quarter of 2022. This represents an 28% increase in reported crimes. The clearance rate for 2023 was 48% compared to 52% clearance rate in 2022.

# Homicides and Attempted Murder:

There were no homicides reported but one attempted murder was investigated in mid October of 2023. As a result of an intimate partner altercation between a 27-year-old female and a 22-year-old male, the female was charged with attempt to commit murder, aggravated assault and possession of weapon for dangerous purpose.

There was no homicides or attempted murders reported during the fourth quarter of 2022.

# Robberies:

There were 12 robberies (0 unfounded) with a clearance rate of 25% reported in the fourth quarter of 2023 compared to 7 robberies reported in 2022 with a 14% clearance rate. This represents a 71% increase in robberies.

# Break and Enters:

During the fourth quarter of 2023, there were 62 break and enters reported (4 unfounded) for an actual of 58 with a clearance rate of 19%. This is a 24% increase from the 50 break and enters (2 unfounded) reported in the fourth quarter of 2022 with a 23% clearance rate.

# Motor Vehicle Thefts:

There were 25 reports of motor vehicle thefts (5 unfounded) for an actual of 20 during the fourth quarter of 2023 with a clearance rate of 10%. This represents a 19% decrease in motor vehicle thefts compared to the 31 reports of motor vehicle thefts (10 unfounded) for the fourth quarter of 2022 with the same clearance rate.

# Assaults:

A total of 129 assaults (13 unfounded) were reported in the fourth quarter of 2023 for an actual of 116 with a clearance rate of 80% compared to 88 (6 unfounded) for an actual of 82 assaults with a clearance rate of 77% reported for the same period in 2022. This represents a 47% increase in reported assaults.

# Sex Offences:

There were 38 sexual offences reported (3 unfounded) for an actual of 35 during the fourth quarter of 2023 with a clearance rate of 51%. This represents a 58% increase compared to the 24 (2 unfounded) sexual offences reported during the same time period in 2022 with a 77% clearance rate.

## Frauds:

There was a 71% increase in frauds reported for 2023. The fourth quarter reports indicate 108 frauds reported (11 unfounded) for an actual of 97 with a clearance rate of 9% compared to the 63 (1 unfounded) for an actual 62 incidents reported in 2022 with a 26% clearance rate.

## Drug Offences:

There were 31 drug offences reported (0 unfounded) with an 100% clearance rate reported in this quarter. This is a 72% increase from the 18 (0 unfounded) drug offences with an 89% clearance rate reported during the same time frame in 2022.

# Criminal Harassment:

There were 51 criminal harassment incidents reported (17 unfounded) for an actual of 34 with a 62% clearance rate in the fourth quarter of 2023. This represents an 82% increase compared to the 28 (1 unfounded) harassment incidents reported with a 78% clearance rate in the fourth quarter of 2022.

# **Utter Threats:**

There were 56 incidents reported (16 unfounded) for an actual of 40 with a clearance rate of 85% during the fourth quarter of 2023. This represents a 70% increase from the 33 (3 unfounded) incidents reported with a 93% clearance rate in the fourth quarter of 2022.

# Arson:

There were 4 incidents of arson reported during the fourth quarter of 2023 with a 25% clearance rate. This is a 100% increase from the 2 incidents of arson reported in the fourth quarter of 2022 with a 100% clearance rate.

# ViCLAS (Violent Crime Linkage Analysis System):

There was a total of 13 ViCLAS submissions for both **criteria** and **non-criteria** offences identified in the fourth quarter of 2023. This represents a 23% decrease from the 17 ViCLAS submissions for both criteria and non-criteria offences submitted in the fourth quarter of 2022.

- Of the 10 criteria offences, one submission was for the Attempted Murder, three for Attempted Abductions and six were for Sexual Assaults. Criminal charges were laid on the Attempted Murder and three of the Sexual Assault incidents. Investigations are continuing for one of the Sexual Assault and one of the Attempt Abduction incidents.
- The 3 remaining non-criteria offences consisted of one Harassment and two Suspicious Persons submissions. Criminal charges were laid on the Harassment incident.







### INFORMATION FACTORS:

The annual stats overview is a high-level insight into several areas of our call response and investigations.

In 2023 there was a 7% increase in calls for service which equated to 29375 calls or an increase of 1945 calls for service over 2022.

There was a 24% increase in 2023 in bail hearings and this is because the courts returned to the process of having in person bail hearings. You will also note that there was a 24% increase of security screenings at the front of the courthouse. Again, this is attributed to the in-person bail hearings and the in-person court hearings for trials.

It should be noted that there was a 97% increase in prisoner transports, for the same reasons as stated above.

In 2023 we experienced a 108% increase in persons arrested day of previous day, which is not captured in the prisoner transport stats.

In 2023 we observed a modest increase of 12% in the area of Criminal Record Checks, over 2022, for a total of 4387 criminal record checks.

There was a 3% in total crimes reports in 2023, which again is good news.

The homicide rate remained constant in 2022 and 2023 at two. However there were three attempted murders which is an increase of 50% in 2023.

There was an 11% increase in the number of robberies in 2023 over 2022

We experienced an 8% increase in break and enters, while motor vehicle thefts decreased by 3% in 2023.

There was a 1% decrease in the number of assaults reported and a 10% decrease in the numbers of sexual assaults in 2023.

In 2023 we experienced a 10% increase in fraud calls for service and a 25% decrease in the drug offence calls for service.

In the area of Criminal Harassment calls we saw a 16% decrease and an 1% decrease in Utter threats calls for service in 2023.

In 2023 we observed a 71% increase in arson calls for service and this is something that we will monitor closely for 2024 to ensure this was an anomaly and not a trend.

We experienced a decrease of 11% in the number of ViCLAS (Violent Crime Linkage Analysis System) submissions, we believe this is due to the decrease in the number of sexual assaults.

The mental health calls for service are difficult to analyze as not all calls involving mental health elements are recorded due to the mandatory coding index we use.











Persons Arrested Day of or Previous Day Quarterly




Persons Arrested Day of or Previous Day 2021/2022/2023






## Homicide/Attempt Murder Quarterly 2021/2022/2023




Motor Vehicle Thefts Quarterly 2021/2022/2023


Assaults Quarterly 2021/2022/2023


## Sex Offences Quarterly 2021/2022/2023


Frauds Quarterly 2021/2022/2023


Drugs Offences Quarterly 2021/2022/2023







Re: Catch and Release

At its Council Meeting of February 13, 2024, the Council of the Corporation of the City of Cambridge passed the following Motion:

WHEREAS this council believes that the safety of our community and its protection from crime in all its forms is of utmost importance.

WHEREAS our taxpayer-funded judicial system exists to protect the public, who in return for their tax dollars are entitled to a system that works.

WHEREAS the number of charges laid for failure to comply with court orders – primarily failure to comply with the terms of a promise to appear, undertaking, recognizance, probation order, or peace bond – are steadily on the rise in the province of Ontario.

WHEREAS there has been a notable increase in the number of violent offences committed in the province of Ontario by individuals who are concurrently subject to release orders.

WHEREAS the Ontario justice system is backlogged, court systems under strain, and police and prosecutors overwhelmed by their caseloads.

WHEREAS we have seen a dramatic lowering of the threshold for release, resulting in violent, serious, or repeat offenders who should by rights have been reasonably detained in custody, released on supervision plans that are increasingly deficient.

WHEREAS the general sense among the criminal population is that breaching bail conditions will not result in much by way of consequence for the offender, as evidenced by a clear pattern province-wide of unjustifiable release, a pattern which is bound to continue given insufficient resources to conduct Crown bail reviews, surety bond estreatment hearings, and ensure the subsequent collection of surety bond funds after judgment.

WHEREAS a 'catch and release' system constitutes a failure of government to perform a core function of its existence, that being the protection of public safety and that this failure constitutes a clear and present danger to the public.



WHEREAS the current hard drug crisis has contributed to a desperate criminal element that is exacting a significant financial and emotional toll on communities across Canada including Cambridge.

WHEREAS our police services are being demoralized by expending precious time and resources having to manage the repeated arrests of these habitual criminal offenders within a system that limits their ability to effectively protect the public.

AND WHEREAS this ineffective follow-through by our judicial system unfairly erodes the public's trust in our police services, who consequently become the target of frustrated and angry residents who feel they are no longer being protected from crime.

AND WHEREAS the increasing erosion of public faith and trust in our judicial system ultimately brings the administration of justice in the province of Ontario into disrepute and leads to a growing feeling amongst residents that they are no longer protected by a system perceived to prioritize the rights and freedoms of the criminal over the rights and safety of themselves and their families.

NOW THEREFORE BE IT RESOLVED, that the City Clerk for the City of Cambridge send a letter to the Right Honourable Justin Trudeau, Prime Minister of Canada, the Honourable Arif Virani, Minister of Justice and Attorney General of Canada, Attorney General of Ontario Doug Downey, Ontario Solicitor General Michael Kerzner, the Honourable Doug Ford Priemer of Ontario, MP Bryan May, MP Valerie Bradford, MPP Jess Dixon, MPP Bryan Riddell, Police Chief Mark Crowell, Waterloo Regional Police Service, all Ontario Police Associations and Police Departments, Ontario Provincial Police, all Ontario MPPs and MPs, and all municipalities throughout Ontario for their endorsement consideration, requesting additional funding in Ontario's legal system to support a meaningful resistance to the current "catch and release" practice, including hiring sufficient court staff, with a specific focus on additional assistant Crown Attorneys.
